



Limited Product Warranty

Ventev One Year Limited Warranty Agreement

Ventev warrants that for the period of one year from the date of shipment the Ventev Class I Div1 and Class I Div 2 Enclosure line products shall be free from defects in design, material, and workmanship under normal use, consistent with product specifications and Ventev instructions. The warranty period commences from the date of product shipment (from Ventev's manufacturing facility) to the end-user customer or, in case of resale by a Ventev Reseller, the date of shipment to the end-user customer, no later than 90 days after original shipment of the product by Ventev. A valid proof of purchase is required for warranty service

Customer must:

- Provide a written notice to Ventev during the Warranty period to provide Ventev to include
 - Sufficient information as to the nature and extent of the defects
 - The uses to which the enclosure had been put prior to the defect arising
- Provide Ventev a reasonable opportunity to examine the defective Enclosure; and
- Return the defective Goods to Ventev at the Customer's expense

The warranty is applicable to Ventev Class I Div 1 and Class I Div 2 Enclosure products only and is limited to repairing, replacing, or issuing a credit solely at the discretion of Ventev after evaluation of the returned product. If Ventev issues a credit, the amount shall not exceed the product price at the time of purchase. This limited warranty only extends to the original end user of the product. The warranty period for a repaired or replaced product is 90 days from the shipment date or the remainder of the unexpired term of the original warranty period, whichever is greater.

Return Material Authorizations (RMA): Customer must contact Ventev Support to obtain the RMA number prior to returning product to Ventev. The RMA number is necessary to ensure proper tracking and handling of the returned product. Without the RMA number, Ventev reserves the right to refuse receipt of the returned product. Customer is responsible to adhere to Ventev's RMA procedure. All shipping and handling of unit to and from the Ventev repair facility is the responsibility of the customer. Any remedies under this warranty are restricted to repair or replacement of the defective product.

Restrictions and Exclusions: This limited warranty does not apply if the enclosure solution, including any hardware inside:

1. Has been altered or modified, except by Ventev or its authorized representative;
2. Has not been stored, installed, operated, maintained, or repaired in accordance with Ventev installation guidelines;
3. Has been subjected to abnormal physical or electrical use, abnormal environmental conditions, misuse, negligence, accident, or used for evaluation, testing, or demonstrations;
4. Has been subjected to acts of God, which may include, but are not limited to fire, water, wind, or any other cause beyond the range of the intended use;
5. Where the fault is with any materials supplied by the Customer to be incorporated into the enclosure; and/or
6. Has been subjected to acts of theft or vandalism.

Discoloration of Ventev enclosures from environmental atmospheric conditions, including UV exposure and metal oxidations, is considered normal and is not covered under the warranty.





Limited Product Warranty

Ventev's Class I Div 1 Enclosures, Class I Div 2 Enclosures, Power over Ethernet (PoE) Heated Enclosures, and PoE Heated and Cooled Enclosures are excluded from this warranty.

Disclaimer: This is an exclusive warranty. Any remedies under this warranty are restricted to repair, replacement, or credit. Ventev is in no way liable for uninterrupted or error-free operation; coverage for any loss of profits, loss of use, costs for removal or installation of defective equipment, damages or consequential damages based upon equipment failure during, or after, the warranty period. There is no warranty for loss of data – you must regularly back up the data stored on your product to a separate storage product. Ventev makes no other representations or warranties, express or implied, and specifically disclaims and excludes any representation or warranty of merchantability, no infringement, or fitness for a purpose and any representation or warranty arising by usage of trade, course of dealing, or course of performance. Ventev's total liability for any claim or damage arising out of or in connection with the manufacture, sale, delivery, or use of the products will be limited to proven direct damages, not to exceed the purchase price of such products. In no event will seller be liable for any indirect, special, incidental, consequential, or punitive damages, including, without limitation, any claim for loss of actual or anticipated revenues or profits. These limitations on liability will apply regardless of the form of action, whether in contract, tort, strict liability, or otherwise, and whether the damages were foreseeable. The terms and conditions contained herein and the rights of the parties to any transaction to which they relate shall be governed by and construed in accordance with the laws of the State of Connecticut, U.S. The United Nations Convention on Contracts for the International Sale of Goods shall not apply. When used herein, Ventev means the Ventev division of Hubbell Solutions and its affiliates, representatives, owners, subsidiaries, employees, and assignees.
